Rules

- Entry deadline is April 29, 2024. Late entries may be accepted at the discretion of the Competition Organizer (with a \$20 Late Entry Fee). No refunds after entries received.
- Age as of May 11, 2024.
- Scrutineering shall be conducted as recommended by RSOBHD. Dancers will be judged according to the technique of the RSOBHD. The judge's decisions will be final and there will be no access to the judge's sheets.
- Age categories will be based on the number of registrations in each classification. First to enter, last to dance.
- Dancers will pick up their numbers at the registration table upon verification of their current RSOBHD card.
- Medals and trophies will be awarded in all categories except in Primary where no trophy is awarded. The oldest Premier group will receive cash prizes for 1st, 2nd, and 3rd placings.
- Mother's Day Fling and Hornpipe will not be included in the High Aggregate.
- Dancers must report to Marshalling Area when their group is called or risk disqualification.
- No coaching while dancers are on stage. Teachers and parents WILL NOT BE PERMITTED in the lineup area, unless assigned as the Marshall.
- Designated change areas will be provided. There is to be no changing in public areas, nor will the dancers be permitted to be in public areas wearing bra tops or sports bras with dickies. Please ensure that dancers are ready to dance when they arrive in Marshalling area as Marshalls are not permitted to fix costumes.
- Dancers must be in full dress to receive awards (including slippers).
- No flash photography while dancers are competing on stage.
- Any protest must be lodged in writing and postmarked within 48 hours, accompanied by a fee of \$25 which will be returned if the protest is upheld.
- The Smith Highland Dancers will not be responsible for lost articles, accidents, injuries or illness to competitors or spectators at the competition.

SCOTDANCE CANADA COMPETITION/WORKSHOP WAIVER FORM:

I am aware that participating in the Guysborough Highland Dancing Competition involves the potential for risks, dangers, and hazards, including but not limited to:
